2024 Election Results: Crisis and Opportunity

Election Season in MelroseBy Kate Ellison

September: Jane Arrowsmith Edwards

Eight generations of Jane's family have lived in Florida. She taught for 20 years and now edits and writes plays and fiction in Gainesville. She's a rockhound who loves the springs, kayaks the gulf, and campaigns to protect Florida. In the 1980s she organized a rally with keynote speakers Marjorie Stoneman Douglas and Sen. Claude Pepper. She came to our September meeting to talk about Amendment 2 on our November ballots. Here are some excerpts from her speech.

"This Trojan horse called Amendment 2 uses heartwarmingly folksy and vague words: to fish and hunt 'by traditional methods' and 'by preferred means.' However, 'traditional and preferred' may include regressive, outlawed methods, such as gill nets, spears, poisons, clubs and metal traps. All became illegal with good reason: they are inhumane and/or indiscriminate." Floridians already have a right to fish and hunt. This amendment legalizes barbaric, painful methods of killing animals. It allows for fish nets that scoop up unintended, possibly endangered species.

"The vast schools of grouper, redfish and snapper that once swam our coastline are no more. It's estimated that grouper and snapper



have been overfished by 85%. Florida statute forbids gill nets, called 'walls of death,' that capture manatees, turtles, dolphins and sharks instead of the targeted fish. When nets are abandoned or torn loose by storms, they snag and doom marine life for years. Regulation is vital.

"Nevertheless, the amendment, [originally written by the NRA,] seeks to 'establish traditional methods [of hunting and fishing] as a public right and preferred means of responsibly managing and controlling fish and wildlife,' even though nonlethal methods of wildlife management have proven highly effective. This wording is used for no other right in our constitution, including our


fundamental rights — and including the right to protect our private property from armed hunters." Lawsuits will invariably ensue, but the right to protect our own property from hunting is in jeopardy with this proposal.

"Amendment 2 is a wolf in sheepskin intended to disarm the protections put in place decades ago. It stokes the red-white-and-blue sentiments of beloved traditions and Godgiven rights to the great outdoors. But rolling back protections of our wildlife could destroy our 'public right' to enjoy Florida's gifts. Our rights to hunt, fish and protect our property will remain secure" and relatively humane "only if we reject Amendment 2!" Jane told us. Clearly, the rest of the public was not listening. Amendment 2 passed easily on November 5, and Florida environmentalists and animal rights advocates are dreading the results of this vote.

November: Richard Segall stares our defeat in the face

The election was a bitter pill, and Democrats are still reeling, especially here in North Central Florida where we are so outnumbered. The Cities of Gainesville and Palatka are bright (blue) exceptions to the sea of dark red we swim through daily. Our November meeting was shortly after the election, and Richard Segall parsed the local results for us, looking at the outcome in the precincts that comprise our Lakes Area. The election had not been certified by then, so his data was the unofficial results. His PowerPoint was emailed to all our members after the talk.

Our high turnout did not help us. As with the rest of the state, the MAGA Republicans swept most of the offices, statewide and local (except in Gainesville). The Harris Walz ticket got between 12 and 34% of the vote in our precincts (22% overall). Although it varies by precinct, registered Democrats are about 20% of the electorate. Even when combined with all



other parties and no party, we add up to only 40%. The GOP's 60% of the vote means they will almost always win.

Their primaries are often more contested and livelier, with the election outcome frequently decided in those primaries. That encourages some Democrats to register Republican just so they have a voice in who gets elected, further weakening our party.

"The objective of the organization [National Federation of Democratic Women, of which we are a part] is to unite women of the




Democratic Party; to promote the cause of the Democratic Party and to encourage full participation of women in every level of the Democratic Party Structure." We intend to "raise the visibility and viability of the Democratic Party and turnout voters for Democratic candidates and issues." How are we addressing this?

GOTV alone is not a winning strategy if we are so outnumbered; we just don't have the votes. Voter protection saves votes we already have; it does not add to our vote count. The GOP was in control of redistricting, and ensured their dominance through 2030. Democrats' messaging relied too heavily on support for Amendment 4, which lost mightily in our precincts, and on the fear of fascism. We don't have a solid ground game in

between elections, and we have not effectively countered how MAGA has defined us.

What was missing? It is the answer to the question, why are you voting Dem? We need a real message, tailored to our area, we need a better ground game, reaching people who are willing to talk. We need to be talking about local issues relevant to our population and show how our values and policies address them. For example, there is no maternity room in Bradford or Putnam County hospitals (Bradford only has an ER). Why are there so many homeless and hungry? Republican policies, that's why. Basically, we need to be talking with more people, reaching outside our groups.

The Chelsea Girls


Growing up in the 1950's was not the idyllic decade one remembers. This is evidenced once more in the historical novel *The Chelsea Girls* by Fiona Davis. Most of the story is set in the theatre district of New York City in the 50's and offers insight into the entertainment industry struggling under the threat of the McCarthy Era.

The book is divided into acts rather than chapters and begins when the main characters Hazel and Maxine meet as USO entertainers in Italy during world War II. Both women have strong personalities and some vulnerabilities as we follow their twenty-year relationship. After the war they reconnect at the iconic Chelsea Hotel. Hazel is now a struggling first-time playwright, and Maxine is an up and coming actress.

Hazel's play is based on their experiences with the soldiers in Italy. In June 1950, as the play moves forward, the actors, actresses, costume designers, and set builders become aware of pamphlets being circulated with over 150 names of communist sympathizers. The residents of The Chelsea are also under surveillance.

Hazel's name is on a list because she attended a pre-war rally with her brother. She is fearful her play will be shut down even before it starts and feels responsible for all of the

performers and employees under her. As she works to get "off the list", the costume designer is removed from the theatre by the FBI and they don't hear from him for months. There are questionable characters lurking throughout the story.

The portrayal of this destructive period of history is intertwined within the characters' lives, allowing us to feel the paranoia and hysteria as they struggle to make the "show go on". Twists and turns in the story make you wonder "who's next?"

The final element to the story is the Chelsea Hotel itself which still exists today. The quirky, artistic personalities who live there provide amusing interludes. Fiona Davis is known for her New York stories. Her historical fiction novels are set in New York landmarks such as the Barbizon Hotel, the Public Library and Grand Central Terminal.


He wants to reduce the corporate tax rate from 21% to 15% "for companies that make their products in America" and cap credit card interest rates and car insurance rates.


